- a. We recommend that the Rosary be held at 9:15 a.m., Eulogy at 9:45 a.m. and the Mass at 10:00 a.m.
- b. However, the rosary may be held the night before the funeral liturgy at 6:00 p.m. or 7:00 p.m.
- c. The eulogy is to take place after the rosary (evening or morning), No eulogy after the Funeral Mass.
- d. If the rosary is held in the evening, the body may remain in the community room of the church after the service.
- e. Vigil service after rosary must be pre-approved by Pastor and may not go past 9:00 p.m.
- f. The casket may be opened for viewing before the rosary and before the funeral liturgy. This takes place in the community room. The Bishop has directed that there be no viewing after the funeral service, but it may be done at the cemetery.

FUNERAL SERVICE

- a. The funeral service is to dwell primarily upon the resurrection and the afterlife. Preaching will be done by the priest or deacon.
- b. Flowers and other memorabilia (pictures, etc.) may be placed in the community room and **not around the altar or in the sanctuary**. These are to be removed after the funeral service.
- c. The piano, organ, ambo or altar, are not be moved.
- d. Additional Chairs: If more chairs are needed, please take them from the Tekakwitha Center NOT Andary Hall. Chairs must be returned to their original place **no later than 2:30p.m., otherwise a \$50 fee** will be charged.
- e. No animals (pets) other than seeing-eye dogs are allowed in the church. Red chairs belong in the community room, green in the Tekakwitha Center.
